Message from the special administrator

I advise that Rangelea Holdings Pty Ltd's (Rangelea) application for special leave to appeal from the judgment of the Supreme Court of South Australia's Court of Appeal was refused by the High Court of Australia on 7 August 2025.

This means Rangelea has no other way of appealing and must accept the decision of the SA Supreme Court that the Adnyamathanha Master Trust is not a charitable trust, and that Rangelea must provide access to its trust records.

On 21 August 2025 the SA Chief Justice made orders:

- By 4 September 2025, Rangelea must produce to ATLA's lawyers records for the Adnyamathanha Master Trust for the period from 30 June 2018 to 30 June 2025, and the Traditional Owner Register.
- The Inspector is to continue his investigation into Rangelea's administration of the Adnyamathanha Master Trust, including any distribution to and use by the Sub-Groups and Sub-Group members.
- The Inspector is to report to the Court within three months.
- A hearing has been scheduled for 25 November 2025 for further directions / orders from the Court.

The Inspector, Mr Hugh McPharlin of Nexia Edwards Marshall, will now continue his investigation into the administration of the Adnyamathanha Master Trust by the trustee, Rangelea . The Inspector is appointed by the Court and reports directly to the Court. The report is due to be finished by 21 November 2025. Compensation money (85%) will continue to be held by the SA Supreme Court while the investigation is conducted by the Inspector.

- 1. Within 14 days, the respondent is to produce to the applicants by production to their solicitors, LK Law:
 - 1.1 those records in relation to the administration of the Adnyamathanha Master Trust (Master Trust) as specified in regulation 5(1)(k) of the Trustee Regulations 2011 (SA), for each of the financial years ending 30 June 2018 to 30 June 2022; and
 - 1.2 to the extent not otherwise produced in compliance with order 1.1 above, the Traditional Owner Register as maintained by the respondent, and as amended from time to time over the same period,

for the purposes of the administration of the Master Trust.

- 2. Mr Hugh McPharlin is appointed, pursuant to section 84C of the Trustee Act 1936 (SA) (Trustee Act), as an inspector (Inspector) to investigate the administration of the Master Trust, including in respect of any funds distributed by the respondent to the Sub-Groups and the use, application and/or further dissemination of those funds by the Sub-Groups (including to any members of the Sub-Groups and in what amounts and proportions).
- 3. Within 30 days of appointment, the Inspector is to provide an interim report to the Court, which outlines the anticipated scope of his task, an estimate of when he will be in the position to provide a final report including an estimate of fees, and any additional information or assistance that he may need in order to produce that report.
- 4. The matter is adjourned to Wednesday, 7 June at 9.30 am for further directions following the delivery to the Court of the Inspector's interim report.
- 5. The respondent is to pay the applicants' costs of the hearing and determination of the ATLA action as agreed or as taxed in default of agreement.
- 6. By 5.00 pm on 5 June 2023 the parties are to provide an agreed regime for the making of any confidentiality applications in respect of the documents referred to in order 1.
- 7. Order 1 is stayed until 7 June 2023 subject to the respondent providing an undertaking by 5.00 pm on 28 April 2023 that it will cooperate with Mr McPharlin by informing him:
 - 7.1 of the nature and extent of the records it keeps in respect of the Master Trust and the form of those records; and
 - 7.2 of the extent and form of any records it keeps of distributions within Sub-Groups

so as to facilitate the provision of the interim report.
