11. 2023FY Financial Report

The financial report of the Corporation in respect of the 2022-2023 financial year was presented by George Treloar noting that the corporation made a profit of \$144,169.12 and held net assets of \$81,179 as at 30 June 2023. The Corporation is solvent and is able to pay its debts when they fall due.

The financial report of the Adnyamathanha Traditional Lands Trust in respect of the 2022-2023 financial year was presented by George Treloar noting that the trust made a loss of \$16,110.91 and held net assets of \$801,634.63 as at 30 June 2023.

12. Appointment of Auditor

Moore Australia has recommended PKF Adelaide to audit the ATLA Group for the next 3 years

- a. Rangelea Holdings Pty Ltd v ATLA, appeal update
 - i. ATLA is currently waiting for the appeals board to make a decision around Rangelea's appeal
- b. Corporation Advisory Group and CHANT
 - i. CHANT cannot and is not making Native Title decisions, a common law holders meeting is needed for these decisions
 - ii. After the damage at the Nilpena National Park border ATLA has engaged a lawyer and is pursuing action around this damage. National Parks has agreed to a survey on this damage.

- i. Wilpena Pound Resort is currently located on culturally sensitive land currently, look into potentially moving the resort off of this land.
